## THE JUDGES

## Zara Ballara

### \*Classical

### \*Waiata Te Reo Māori

Born in Ōtautahi (Christchurch), Zara returned in 2012 after a 16-year career of performing and teaching in London. She started lessons aged 8 and worked her way through traditional graded classical exams in preparation for her formal studies at Victoria University, Wellington with Emily Mair. In 1996 she married fellow performance student Carlo Ballara, and together they headed for London.



She completed her postgraduate studies at the Guildhall School of Music and Drama, and in 2000, won the prestigious Maggie Teyte prize. In 2002 she made her début at Wigmore Hall, London, performing '**Encantos The Songs of Spain'** for the Company of Singers and Players. Zara has sung as a solo artist throughout the UK and Europe, but since starting a family has focused her efforts on voice teaching, both peripatetically and privately.

For the past 10 years she has led the Classical Voice Programme at Canterbury University supporting all tertiary levels, encouraging and inspiring the next generation of singers.

Now that her sons are older, Zara has begun two life-changing and fulfilling journeys. Firstly, pursuing a DMA. Her research is focused on integrating waiata Māori into the classical hybrid art song form while investigating the compositional elements through the songs of Georgia Stitt and folksong arrangements by composers such as Benjamin Britten and Aaron Copland. Her findings will then be used to arrange 18 traditional published Māori waiata. As a disconnected, urban Māori, Zara has also begun her Te Ao Māori journey. She has started to address her feelings of 'not being Māori enough', by learning te reo. She is studying through Te Wānanga o Aotearoa and finding her place through the study of waiata Māori. Her aim is to create a recital programme of beautiful waiata, to be shared with students and audiences across Aotearoa. She believes that songs are the caretakers of our stories, traditions and culture - treasured taonga which need to be celebrated and shared.

## Arlie McCormick

Arlie McCormick is a highly accomplished vocalist, educator, and theatre professional based in Dunedin, Aotearoa New Zealand. Holding a Master's Degree in Vocal Pedagogy from Griffith University, Brisbane, Arlie has been a significant contributor to the New Zealand singing community for nearly nine years. Currently, she serves as a Senior Professional Practice Fellow at the University of Otago, teaching Contemporary and Musical Theatre Voice to Bachelor of Music and Bachelor of Performing Arts students.

Her passion also extends beyond academia. As the President of the New Zealand Association of Teachers of Singing (He Wai Kōmako), Arlie travels extensively throughout Aotearoa, conducting workshops and masterclasses, sharing her innovative teaching methods. Arlie's own performance history is equally impressive, boasting leading roles in numerous productions



including Calamity Jane, I Love You, You're Perfect, Now Change, The Boy from Oz, and Next to Normal. She also achieved an OSTA Award for her performance as the Bird Woman in Mary Poppins.

In addition to this, Arlie's theatrical experience encompasses both on-stage and off-stage roles. She has served as Vocal Director for productions such as Jersey Boys, and as the driving force behind her own theatre company, Pop Up Productions, producing shows like Heathers the Musical and Spring Awakening. Prior to relocating to Dunedin, she was a member of the acclaimed cabaret quartet, Babushka, touring extensively throughout Australia, performing at prestigious festivals including the Wonderland Festival, Brisbane Cabaret Festival, and Adelaide Fringe Festival.

Her recent achievements include a guest spot with the legendary Jackie Clarke in her DIVA show, and the creation of her one-woman show, "What's It All About Arlie?" – An Evening of Burt Bacharach and Friends, at Dunedin's Regent Theatre, co-created with Musical Director Stuart Walker. Arlie also served as both Vocal Director and Soloist for the Dunedin Symphony Orchestra's (DSO) ABBA show and will be a featured Soloist in their upcoming Simply The Best concert in November 2025.

Arlie is excited to share her expertise and passion for music with the talented performers of New Plymouth for their upcoming Vocal Competition.

## **ENTERING THE COMPETITION**

### **Entering the New Plymouth Competitions**

Entries open on Monday 7 April at 7pm.

Entries close on **Sunday 21 April at 7pm** or earlier if capacity is reached.

All registrations for the competition are by the Glide app, which is found via our Facebook page (New Plymouth Competitions Society-Vocal Section) or NPCS website <a href="https://www.newplymouthcomps.com">https://www.newplymouthcomps.com</a>. We expect that some classes will reach capacity quickly, so we recommend pre-registration in the app prior to entries opening. Payment is required at the time of entry. Song titles are not required at time of entry so get your entry and payment in and confirm your spot before it's a sell-out! A wait list may be available.

### Programme and Backing tracks App

We will be operating a live programme, using the Glide app. It is essential that you complete your Competitor Profile, Song Titles and upload any backing tracks into the Glide app by 21 May 2025. Once you have completed your registration and payment, you will be emailed instructions on how to do this.

Song changes will not be permitted after **21 May 2025** as many details have to be checked by the convenor and judge: correct genre, age suitability and previous wins. The judges also need time to familiarise themselves with the songs.

Use the help button on the app if you require assistance, however we cannot upload the music for you. Your music will be played from the app on the day, but ensure you also have a copy of your music on your phone as a backup only.

Please note that backing vocals are not permitted on backing tracks – If backing vocals are on your music backing track you will receive a 5 mark penalty. Note: "Oo"s and "Ah"s are considered to be backing vocals and are not permitted.

## **GENERAL RULES**

1) **ELIGIBILITY:** Any song that a competitor has won a Class with at NPCS Vocal Competitions in 2022, 2023 or 2024 is not eligible.

An email will be sent to all competitors after entries close asking for:

- \*song titles and genre
- \*eligibility for Restricted Award
- \*eligibility for True Colours Award

<u>Restricted</u>: Intermediate, Secondary and Open classes have a cup for a Restricted competitor. This means a competitor who has not won a first placing at any singing competition before this competition.

<u>True Colours Award</u> is given to a competitor who has overcome significant difficulties to perform.

All sponsored prize money must be signed for by the recipient or the guardian prior to it being received.

Entertainment Classes entry restrictions: All competitors may enter up to two (2) maximum entertainment classes regardless of age. The two items must be different combinations of competitors.

- 2) **JUDGES' REPORTS** will be available in the app for you to download. They will not be printed out for you on the day. Please note the Entertainment section will be scored only and there will be no judge's reports. These scores will also be in the app.
- 3) **THESE COMPETITIONS** are open to entrants whose income is not in excess of \$2000 per annum derived from the exercise of his or her talents in the section in which he or she may compete, excluding Open Classes.

No Competitor who has been taught or coached by the Adjudicator of that section during the two years preceding the Competitions Festival will be allowed to compete in that section. This excludes Masterclass situations.

- 4) **OPEN CLASSES** are open to all competitors (either amateur or professional) irrespective of earnings.
- 5) AGE is as of **06 June 2025**.
- 6) **ENTRY FEES:**

All Fees must accompany entries.

N.B. Duos, Trios, Duets and Ensembles / Groups are to be entered and paid for by one performer only – please include the names of all performers / group names on the entry form where known.

The entry fees for all classes are as follows:

- \* Admin fee for families with one child \$20.00
- \* Admin fee for family with two or more children \$30.00
- \* The Admin fee is payable once per family across all genres
- \* Entry fee (single) \$12.00 per item
- \* Entry fee for Entertainment Classes and Waiata Te Reo Māori Class \$15.00 per item
- \* PACANZ Entry Fee \$25

- 7) **VIDEO RECORDINGS**: Private Video Recording of your own child is permitted providing it does not interfere with their performance.
- 8) **FLASH PHOTOGRAPHY**: Is not permitted during the performance.
- 9) This year Sandra from Antill Photography will be photographing singers on stage. These stunning photos can be purchased at just \$5 per image from an online gallery in the week following the event. Check our Facebook page for the link after the competitions.





- 10) **CERTIFICATES** will be awarded for 1st, 2nd, 3rd.
- 11) **ORDER OF PERFORMANCE:** Competitor's names will appear in the programme in the order in which they compete, but all competitors must be in attendance at the time of commencement of their class. Those not present when called upon shall be liable to forfeit their right to compete.
- 12) **PROTESTS**: Any person wishing to enter a protest must lodge the same in writing with the Secretary together with a statement of the grounds on which it is based and enclosing \$5.00. Should a protest on investigation be deemed to be frivolous or unfounded, the deposit will be forfeited. No protest will be entertained unless made within twelve hours after the Adjudicator's award is announced in that particular item. The decision of the Protest Committee (President, Vice President and Section Convener) shall be final.
- 13) **ITEMS MUST VARY:** Competitors will not be permitted to perform the same item in more than one class.
- 14) **PROMPTING**: No prompting or assistance of any kind may be rendered during a performance except by the Adjudicator. Prompting of any kind may result in the disqualification of the competitor by the adjudicator.
- 15) **REHEARSALS**: Rehearsals will be possible for the Contemporary and Entertainment classes on Friday 6 June 2025 4pm-8pm and Saturday 7 June 2025 9am-12pm in the church auditorium. There will be a fee and a booking schedule.

- 16) **CUPS AND TROPHIES:** Are the property of the Society and are held by the winners until returned to the Section Convener no later than **1 May 2025**. Engraving of cups and trophies is the responsibility of the winner. Note If trophies are unable to be hand delivered then they MUST be couriered to the Convener's address, 30A Rossiter Crescent, New Plymouth. Posting is not accepted by the Society due to trophies going missing in the past. Late returns will result in a fine of \$30.00 to defray expenses in tracing cups. If a cup is returned uncleaned you will be charged \$20 for someone else to do this. Failing to comply with the above the competitor may jeopardise eligibility for awards & scholarships. Please respect the owners and sponsors of these expensive items.
- 17) **FAILURE TO FINISH ITEM:** If a Competitor leaves the stage for any reason during their item they might be permitted to return at the convenor/judge's discretion.
- 18) **CONDUCT & OBLIGATIONS**: Communication with the Adjudicators, either by Competitors, Teachers or other interested parties, prior to, or during the Competitions is strictly prohibited, and the Committee reserves the right to disqualify any Competitor who breaches this rule. Committee members and official helpers are permitted to speak to the Adjudicator on their official duties only.
- 19) **RESULTS:** Entry into these competitions constitutes your permission to publish results and photos. Results and photos will be posted on the website and Facebook page.
- 20) **REFUNDS**: Entry fees are not refundable. If this competition has to be cancelled due to events outside of the Society's control, any entry fees paid will be returned minus the Administration Fee which will be kept to cover costs incurred for the event.

## PACANZ MUSICAL THEATRE

## 2025 Criteria for Musical Theatre

This is only the second time that this class has been offered in New Zealand. It is a very exciting event to be part of. The standard at this competition is very high and we request that anyone entering this class is performing at a Grade 8 standard or higher.

- A. Competitors shall be 15 and under 25 years of age as at **1 October 2025.**
- B. Each competitor shall perform in three classes during the preliminary round:
  - 1) Piece 1: Stand alone, independent piece from a fully staged musical and **NOT** from a TV adaptation. Maximum of seven minutes in duration
  - 2) Piece 2: Stand alone, independent piece from a fully staged musical and **NOT** from a TV adaptation. Maximum of seven minutes in duration
  - 3) Master Class run by the Adjudicators. No audience observation.
- C. The two Pieces in B1 and B2 must **NOT** be from the same Musical and **MUST** show breadth of repertoire with Piece 2 showing a clear contrast to Piece 1.
- D. Both Piece 1 AND Piece 2 MUST each include at least one example of scene into song.
- E. The spoken excerpt of the scene into song, can be taken either from the original published musical theatre work OR devised by the competitor and should develop character and story.
- F. Both Piece 1 and Piece 2 **MUST** feature the integration of acting, singing and dance and competitors must perform all three.
  - 1) Piece 1 Dance heavy, up-tempo, must include a specific dance section of a minimum of 16 Bars
  - 2) Piece 2 Dramatically heavy, use of appropriate movement and blocking to add to the story
- G. Props are permitted but they must be handheld and not require any assistance.
- H. A backing track MUST be provided and will include music and silence as required for the full performance.
- I. There will be NO cueing from the Stage Manager. The track will be cued at the start of each Piece and will not be touched again.
- J. A penalty of 5 marks will be imposed if the time limit is exceeded by 30 seconds or more.
- K. There will be a semi-final at which competitors will repeat either B1 or B2 at the discretion of the adjudicator. Competitors will be chosen based on their marks in the three Preliminary round(s).
- L. The number of semi-finalists will be decided in accordance with the NYPA rules.
- M. For the Final Award Concert, three competitors will be recalled and shall repeat the item not performed at the semi-final.
- N. Costumes, choreography & music should be appropriate to the age of the competitors and suitable for a family audience this will be at the Adjudicators' discretion.
- O. This competition is for amateur performers only and is not open to professionals\*.

NB: Males can sing female roles and vice-versa. No distinction between genders.

Nomination of competitors by Societies should be based on classes B1 & B2 i.e. with or without the Master Class

## Society Nomination

Each Society, which is a financial member of PACANZ, may nominate up to two competitors, who shall be selected by the adjudicator, based on a performance as outlined in A-D (above).

The adjudicator will determine that a competitor has displayed a sufficient standard of performance to competently represent that society at the National Young Performer Awards.

The standard required will be at the absolute discretion of the adjudicator but will include;

- A demonstration of adequate preparation and an authority of performance
- A performance with a level of maturity commensurate with a national final competition of this age group.

If the adjudicator considers that sufficient standard has NOT been reached by any competitor, then NO nomination will be made.

The Nominating Society is responsible for paying part of the entry fee to the National Young Performer Awards, which is \$75.00 incl gst.

The Nominee is responsible for paying their portion of the entry fee to the National Young Performer Awards, which is \$230.00 incl gst.

### **Direct Nomination**

#### <u>Via a Competition Society Member</u>

If the adjudicator considers that more than two competitors have reached a sufficient standard, the adjudicator may report to the committee that those competitors should be given the option of a Direct NOMINATION.

#### <u>Via a Tertiary Institution Member</u>

Nominations may also be put forward if Musical Theatre students have reached a sufficient standard and can meet the Criteria listed above.

The Direct Nomination competitor will be responsible for paying the full entry fee, which is \$305.00 incl gst.

\* A professional is someone whose primary employment is being paid to perform or work in the performing arts. For the present purposes, being a student constitutes "primary employment" and therefore is not seen as a Professional. For the Student who receives payment for participation, either teaching or performing, this should not impose professional status on a person if it is by way only of an occasional bonus or benefit rather than their principal means of earning a livelihood.

- Time limit is 5 minutes. (This includes set up time)

- Use of taonga Māori is permitted.

#### **GENRES:**

- Classical Solo (pre-1900)
- **20th/21st Century Art Song**. An art song is a vocal music composition, usually written for one voice with piano accompaniment, and usually in the classical art music tradition. It can be in languages other than English.
- **Folk Song/Traditional Song**. A melody of unknown authorship, passed down orally from generation to generation (over a long period of time), often sung unaccompanied, and identified with a particular culture or place.
- **National Song.** National songs have patriotic lyrics (e.g. patriotic hymns), and that might be performed on public or state occasions to represent a particular nation
- Opera Aria
- Lied
- **Sacred Solo** The intentions of the composer are to worship, or sing about God. It will often have Biblical quotes or context. Oratorio is considered a Sacred Solo. Contemporary Christian songs or more modern-styled sacred songs should reflect traditional classical technique, phrasing and interpretation.
- Gilbert & Sullivan

#### **EXAMPLES of GENRE:**

- "Pokarekare Ana" has an unknown composer therefore it is a Folk Song/Traditional song.
- "Home on the Range" is written by Brewster M. Higley & Daniel E. Kelley, therefore it is a National song.
- "Santa Lucia" is a Folk Song. Teodoro Cottrau (1827–1879) arranged the original melody, however he did not compose it.
- "Homeward Bound" is written by Martha Keen, therefore it is a National Song.
- "Se tu ma'mi" is a Classical song as it's not from an opera.
- "Hallelujah" by Leonard Cohen is not a Sacred Solo, it is a secular Contemporary song.
- \*Definitions provided by Associate Professor Dr Jennifer Cattermole- ethnomusicologist at Otago University and Judy Bellingham-former William Evans Associate Professor in Voice at the University of Otago
  - 1. Performances in this section are to be presented in the traditional style, unamplified and with live accompaniment, or unaccompanied. **No backing tracks** are permitted in the Classical section.
  - 2. A short introduction of all pieces is appropriate before singing, which must be included within the time limit. Please consider formal, tidy dress.
  - 3. One entry per competitor.
  - 4. Competitor Profile, Song Titles and a PDF of your sheet music must be uploaded into the Glide app by **21 May 2025.** Song changes will not be permitted after this date.
  - 5. A warm up area is provided follow the signage or ask one of our friendly team members for directions.
  - 6. Judges' reports and scores will be available in the app and will not be printed.
  - 7. The convenor and judge have the final decision re genre criteria. Correspondence will not be entered into with regards genre definition.
